Dear Mission Oaks Recreation & Park District (MORPD) Advisory Board,

Please kindly confirm receipt and distribute to all MORPD board members for Nov 12th, 2024 advisory board meeting.

As a constituent of MORPD, I request the board support the continued the use of Zoom for <u>Advisory Board</u> and <u>Committee Meetings</u> and <u>to ensure constituents and the public can continue to use Zoom to remotely attend, participate and provide public comment live via Zoom</u>.

- Maintaining a hybrid model for public participation is widely adopted by local governments, boards, commissions, committees, etc. and leaders are welcoming public participation and insights to achieve better decisions and outcomes for the public served by the governing body and advisory.
 - See Attachment A below for list of the many local governments, districts, boards, and commissions leading the way on this (i.e., using Zoom and hybrid meetings to engage public).
- Zoom provides an important path of communications and transparency between constituents, district staff, board members, consultants, and others.
- Use of hybrid model of combined Zoom and in-person meetings is widely adopted in the public, it is low cost, and easy to use.
- In a technology enabled world MORPD needs to keep up and embrace use of Zoom (and similar technologies) used routinely in government, schools, and our daily lives.
- The public expects this hybrid live meeting access inviting them to participate remotely from leading organizations interested in better serving and keeping pace with needs of the public they serve.
- While MORPD started using Zoom during pandemic, the tremendous untapped benefits and new information to the district has enabled and it is vital to your success.

The suggestion to investigate discontinuation of Zoom was first initiated by Chair Alcalay at the Feb 13, 2024 advisory board meeting (as recorded in the minutes). It followed a heavily attended Facilities Committee meeting where multiple methods of participation and public comment were used for benefit of the meeting. Unfortunately, MORPD went on to suggest and find ways to reduce public comment time from 2 min to 3 min, to remove existing option of a public comment letter read into meeting by staff (an option many of my own neighbors used in fear of retribution and/or not able to attend due illness), as well as a change to meeting minutes format which summaries now are so sparse that little-to-no useful information about what actually occurred in meeting discussion, facts, public comment, board comment, discussion, reasoning or otherwise could be known (unless you attend live meeting). Entitles who use the limited meeting summary format, that are committed to be transparency, provide recordings of full meetings to public online (including Sacrament County Board of Supervisors). The point is this latest effort is more of same and it's not helpful. It is exhausting and the wrong path to solve issues and achieve success.

How about actually keeping line of communication open, meeting us where we are by letting us continue to attend and participate remotely, actually working on problems together, being open to ideas that help resolve this, and find a way to be supportive and good neighbor... instead of trying to control the narrative and impede?

I hope that wisdom prevails over this latest course of action, and the entire board instead support the continued use of Zoom as stated above. Please let me know if you have questions.
